Abstract

We are a Binance Smart Chain token, with a unique 5% transaction tax that is used to: 1% for liquidity and 4% for wallet marketing. Binance Smart Chain

The Binance Smart Chain (BSC) is a blockchain network that runs in parallel to the Binance Chain. In contrast to the Binance Chain, BSC features smart contract functionality and compatibility with the Ethereum Virtual Machine (EVM). The Binance Smart Chain offers our community the added interoperability of facilitating their investments through Ethereum-based wallets, such as MetaMask. An added advantage of issuing \$LISTENBOURG tokens on the BSC is that it offers our community an affordable blockchain experience through smaller transaction fees compared to the Ethereum Network.

PancakeSwap

PancakeSwap is a Binance Smart Chain Decentralized Exchange (DEX) for swapping BEP-20 tokens. To enable Listenbourg Coin's buying and selling, PancakeSwap offers our community the ability to exchange their BNB for \$LISTENBOURG.

\$LISTENBOURG

Listenbourg Coin (\$LTBG) is a BEP20 token issued on the Binance Smart Chain with a total supply of 10 Millions tokens.


1st cryptocurrency and marketplace of the Listenbourg

We want to give the opportunity to everyone in Listenbourg, and also the rest of the world, to make some business and tourism in Listenbourg.

Creation of listenbourg app

Our end goal would be to facilitate a worldwide marketplace for dealerships to list their inventory for payment with all major cryptocurrencies. In our market research, over 95% of high-end dealerships wish to accept payment in crypto but don't have the knowledge or tools to do so, we will fix this for every company in Listenbourg.

Tokenomics



Tax

The tax aspect of Listenbourg Coin is backed by the imposed 5% tax for all transactions. One percent of this tax is going to the liquidity, 4% in the wallet marketing. There is no plan for the moment for holders who support \$LISTENBOURG but to make it a sustainable movement, something will be done in the future.

The 1% is transferred back as liquidity provider tokens to the PancakeSwap Liquidity Pool (LP). On a weekly basis, a part of the newly accumulated LP tokens will be removed from the liquidity pool and will be appropriated as proceeds to charitable giving.
